Consignment Terms

1. Consignment Period

Bleak House Books (BHB) agrees to carry author's/consignor's books on a consignment basis for 6 months. If the books sell within that period, BHB agrees to pay consignor 60% of the agreed retail price for each book sold.

2. End of Consignment Period, Extensions and Pick Up of Unsold Items

At the end of the consignment period, BHB will evaluate the success of author's/consignor's book(s). If no books were sold, we will ask you to pick them up. If we decide to continue to carry your book, we will extend the consignment period for an additional 3 months, and then evaluate the book(s) again when the additional period has expired.

If we decide to not extend the consignment period, we will ask you to pick up any remaining items. Any books left at Bleak House Books by authors/consignors for more than a month after authors/consignors have been contacted to pick them up will become the property of Bleak House Books.

3. Payment Terms

Book sale payments are made quarterly by the 15th of the month following each quarter (i.e., April, July, Oct., Jan.) **when the amount due is USD \$60.00 or more**. Payments will be made by check and mailed to the address specified above unless the author/consignor supplies a different address to BHB or makes arrangements to pick up payment.

If the amount due is less than USD \$60.00 at the end of a quarter and the consignment period has not yet terminated BHB will roll over the amount to the next quarter; payment will then be made at the end of the quarter or when the consignment period has ended, whichever is earlier.

If the amount due is less than USD \$60.00 at the end of a quarter and the consignment period has come to an end BHB may at its option extend the consignment period and roll over whatever amount is then due to the author to the next consignment period. If BHB decides not to extend the consignment period then it will issue payment of the amount due to the author as per the above terms.

4. Misc. Terms

a. BHB will only pay for items that are sold. Damaged or stolen items are the sole financial responsibility of the author/consignor.

b. All shipping charges, should any be incurred in connection with this consignment agreement, are the responsibility of the author/consignor.
